### I. Purpose

The purpose of this General Order is to provide officers of UW-Whitewater Police Department (UWWPD) with direction regarding the equipment and supplies they are to possess in their vehicle during their shift. This General Order also establishes a system to replenish equipment and supplies.

### II. Definitions

**Canine Vehicle:** Vehicles owned by UW-Whitewater Police Department that are assigned to specific officers with a canine assignment. Because these vehicles are taken to and from work by the assigned officer for transport of UWWPD canines, they are not available for use by patrol officers.

**Patrol Vehicle:** Vehicles owned by UW-Whitewater Police Department that are routinely utilized by patrol officers for responses to calls for service.

**Supervisor Vehicle:** Vehicles owned by UW-Whitewater Police Department that are designated for department supervisors.

### III. Policy

It is the policy of UW-Whitewater Police Department (UWWPD) that the mandatory equipment for vehicles will be available uniformly in all patrol vehicles. Personnel will ensure that the mandatory equipment is present at all times and that procedures for replenishment are followed.

### IV. Procedure

**A. Patrol Vehicle Equipment:** The following equipment will be included in every patrol vehicle:

1. Squad computer;
2. Squad radio;
3. Squad rifle mounting system;
4. Emergency lights and siren;
5. Prisoner transport compartment;
6. Preliminary Breath Test (PBT) with tubes;

7. Medical Kit (may be kept in PD during extreme cold);
  8. Less lethal shotgun;
  9. Go bag;
  10. Ballistic shield;
  11. Vehicle unlock tools (unlock tool, rubber/plastic wedge, pump wedge);
  12. Jump pack;
  13. Fire extinguisher;
  14. Police tape (2);
  15. Stop Sticks;
  16. Dog leash;
  17. Welders gloves (1 pair);
  18. Roadway Emergency Hazard lights;
  19. Ice scraper;

  6. Go bag;
  7. Vehicle unlock tools (unlock tool, rubber/plastic wedge, pump wedge);

  9. Fire extinguisher;
  10. Police tape (2);
  11. Dog leash;
  12. Welders gloves (1 pair);
  13. Roadway Emergency Hazard lights;

- C. Supervisor Vehicle Equipment: The following equipment will be included in every supervisor vehicle:
1. Squad computer;
  2. Squad radio;
  3. Squad rifle mounting system;
  4. Emergency lights and siren;
  5. Medical Kit (may be kept in PD during extreme cold);
  6. Go bag;
  7. Vehicle unlock tools (unlock tool, rubber/plastic wedge, pump wedge);
  8. Jump pack;
  9. Fire extinguisher;
  10. Police tape (2);
  11. Stop Sticks;
  12. Roadway Emergency Hazard lights;
  13. Ice scraper;
  14. Shovel;
  15. Broom;
  16. Flex cuffs (3);
  17. Gas card;

  19. Traffic vest (2).
- D. Procedures for replenishing equipment
1. Mandatory equipment/supplies should be checked each shift when performing squad checks.
  2. During monthly vehicle inspections conducted by designated officer, squad equipment will be checked and resupplied if needed.
  3. Supervisors must be notified when equipment/supplies reach reorder level or equipment is used from a vehicle.
