DAY 1 Depart the USA: Depart the USA on your overnight flight to Zurich, Switzerland.

DAY 2 Zurich – Basel, Switzerland: Welcome to Switzerland! Upon arrival, you will be met by a representative of Mayflower Cruises and Tours and transferred to your awaiting motorcoach. Flights should arrive by 1:00pm. Journey to the town of Basel where your captain and crew await to welcome you aboard your luxurious Emerald Cruises Star-Ship. Enjoy time to become acquainted with your new accommodations, and this evening, join your fellow guests for dinner onboard. Your Cruise Director will also conduct a port talk to review the activities and itinerary for the days ahead. Meal: D

This afternoon, enjoy a scenic drive through the Black Forest Highlands on your way to the Hofgut Sternen complex located at the foothill of Ravenna Gorge, a place where history and tradition merge. This was the site where, in 1770, Marie Antoinette stopped with 52 beautifully decorated carriages on the way to her wedding to King Louis XVI. During this holiday season, see the picture-perfect Christmas market situated underneath the 130' high Ravenna Viaduct where unique handcrafted regional items await your perusal. Enjoy local entertainment onboard this evening. Meals: B, L, D EmeraldPLUS: Guided visit to the Christmas Market at Ravenna Viaduct

DAY 4 Strasbourg, France: Upon arrival in Kehl (docking site for Strasbourg), travel by coach across the river to Strasbourg,

the capital city of the Alsace Region in France. A local guide leads you on a walking tour through this picturesque town. Stroll along the Grand Île and through the charming Old Quarter, 'La Petit France'. Admire the historical city center and UNESCO World Heritage Site known for its medieval black and white timber-framed buildings, old tanning houses, baroque sandstone buildings, canals and river locks and its centerpiece, the Gothic cathedral. Enjoy free time to visit the stalls of Strasbourg's Christkindelsmärik, one of the oldest in Europe, before returning to the ship. Meals: B, L, D

DAY 5 Ludwigshafen – Heidelberg, Germany: From the port of Ludwigshafen, depart by coach for Heidelberg. Your guided tour of Heidelberg's rich history includes a wine tasting and a visit to the ruins of Heidelberg Castle, overlooking the Neckar River and a red-roofed skyline. A stroll along the cobblestone streets of the Old Town touches on the Church of the Holy Spirit and the oldest university in Germany, further enhancing your visit to this historic city. Enjoy local entertainment onboard this evening. Meals: B, L, D

DAY 6 Koblenz: This morning, enroute to Koblenz, sail through the spectacular Rhine Gorge, where a landscape of castles and quaint towns awaits. Don't miss the infamous Lorelei rock and statue and other photo opportunities that abound around every bend. Cruise to the 2000-year-old town of Koblenz, situated at the confluence of the Rhine and Moselle Rivers. During a walking tour of Koblenz, see the German Corner monument and traverse the cobblestone lanes of the historic city center. A visit to Ehrenbreitstein Fortress, crossing the river via aerial tram, is also included. After the excursion, time to visit more



than 100 glittering, festive, cottage-style stands filled with Lebkuchenherzen (traditional gingerbread hearts) and other special treats and handicrafts, all creating a magical European Christmas experience. Meals: B, L, D

DiscoverMORE: Moselle & Cochem Castle Visit (additional expense)

DAY 7 Cologne: Seven markets transform picturesque Cologne into a winter wonderland over the Christmas season. Following a guided walking tour of the city, be sure to pay a visit to the shopping stalls around the Alter Markt, Neumarkt, Rudolfplatz and the UNESCO World Heritage cathedral, beneath which you'll locate the Christmas tree. Decorated mugs hold steaming hot Glühwein, and local vendors sell handmade sweets and local delicacies at the Christmas market stalls. Meals: B, L, D EmeraldPLUS: Christmas traditions in Europe lecture onboard by the Cruise Director

DAY 8 Amsterdam, the Netherlands: In Amsterdam, board a glass-top canal boat for a morning tour along the UNESCO World Heritage canal system. Pass historic merchant's houses that reflect the bygone era of the Dutch Golden Age, as well as delightful Christmas market stalls. Meander through the Christmas market during your free time to pick up any last minute gifts or souvenirs! Meals: B, L, D

DAY 9 Amsterdam / USA: It's time to bid farewell to the Captain and crew and depart for Schiphol Airport as you say goodbye to Europe and return home with lifelong memories of your Christmas markets cruise along the Rhine River. Meal: B







Payments: All deposits and final payments can be made by check or credit card. We accept the following credit cards: Visa, MasterCard and Discover.

Prices Subject to Change: We reserve the right to vary itineraries and prices and substitute facilities, hotels or events of equal or better quality if necessary.

Guaranteed Share Program for Single Travelers: If you are traveling alone and would like a roommate for cost savings, let us know at the time of booking your reservation. Travelers must be non-smokers, cannot use a medical sleeping device or have specific needs like Handicapped room etc. to be eligible. Participants will be paired with another traveler of the same gender at the twin rate. If no roommate is available, you will get a single room at the twin rate. Guaranteed share reservations are available 180 days prior to tour departure. Guaranteed share reservations are only available on certain Cabin categories. Please call us for details.

Roommate Cancellation: If you are booked as a "twin" and your roommate cancels their reservation, and you cannot find another roommate, you may either travel as a guaranteed share (see above) or travel as a single and pay the single supplement.

Health and Walking on Tour: Some sites visited have limited motorcoach access and may involve considerable walking, stairs or inclines. Travelers should be in reasonably good health. Some programs include destinations in higher elevations that may have varying effects on individual travelers. Tour Managers and Coach Drivers cannot lift or assist travelers into transportation vehicles. Mayflower Cruises & Tours requires that persons requiring assistance be accompanied by a companion who is capable of and totally responsible for providing the assistance.

Revision Fees: A fee of \$25 per person per transaction will be charged for any changes, revisions or alterations made to your reservation after confirmation.

Luggage Handling: The tour cost includes porterage for one average size suitcase. A charge of \$5.00 per hotel will be collected by the Tour Manager for each additional piece of luggage that you bring.

Travel Documents: Your travel documents will be in your possession approximately 14 days prior to departure. Documents include tour itinerary, departure and arrival information and times, hotel and ship information, clothing suggestions, baggage tags, plus any helpful hints.

Mayflower Loyalty Program: Earn \$150.00 travel credit for every River Cruise and Small Ship Adventure taken with Mayflower Cruises & Tours. We will send instructions for visa applications if a visa is required for your tour. Holders of non-U.S. passports should contact their nearest consulate and inquire about the necessary passport or visa documentation required for entry into the countries visited. Visa fees and cost of obtaining a visa are not included in the tour price and are the responsibility of the traveler.

Medical Requirements: Many countries have immunization requirements. Some countries require foreign visitors to have valid medical insurance on entry. Requirements vary by country and can change. Please check with your travel professional or call our office for details on which tours need these requirements. Specific instructions will be sent to you at 90 days prior to departure if your tour requires these conditions. Mayflower Cruises & Tours cannot be liable for delay or denial of entry due to missing documents.

Itinerary Changes: There may be times when we may have to alter the scheduled itinerary, cruise vessels, hotels, shore excursions etc. due to weather conditions or conditions on the river in regards to water levels, locks, or other delays. Any changes in the itinerary due to these conditions will not result in eligibility for a refund. All itineraries are subject to change without prior notice and may need to be altered due to water level and other weather conditions.
