**Upper Division Business Core courses

All business majors are required to take the upper division core of business courses below. In most cases, it is recommended that you complete these courses in your junior year. In some cases, specific core courses are recommended in specific semesters; otherwise, you may take them in either semester of your junior year. The upper-division business core courses are:

FNBSLW 344-Business Finance (*prereq. Account 244*)

ITSCM 306-Operations Management (*prereq. Econ 245*)

FNBSLW 341-Business and Commercial Law

MANGEMNT 301-Organizational Behavior

MARKETNG 311-Principles of Marketing

MANGEMNT 489-STRATEGIC MANAGEMENT is a senior-level college capstone course and has **FIVE PRE-REQUISITES: FNBSLW 341, FNBSLW 344, MANGEMNT 301, ITSCM 306, and MARKETNG 311.**

***Accounting major requirements

Accounting majors are required to take the following courses:

- ACCOUNT 341 Intermediate Accounting I (*prereq. 249*)
- ACCOUNT 343 Intermediate Accounting II (*prereq. 341*)
- ACCOUNT 351 OR 352 Individual Tax OR Business Tax (*prereq. 249*)
- ACCOUNT 354 Accounting Information Systems (*coreq. 341*)
- ACCOUNT 356 Intermediate Managerial Accounting (*coreq. 341*)
- ACCOUNT 465 Auditing (*prereq. 341 AND 354*)
- ACCOUNT 480 Accounting Analytics (*coreq. 465*)
- Three (9 credits) ACCOUNT electives (additional accounting electives can count towards the general elective requirement):
 - must choose *at least* one from this 'advanced' group:
 - ACCOUNT 351 OR 352 Individual Tax OR Business Tax (*prereq. 249*)
 - ACCOUNT 453 Tax Research (*prereq. 351 OR 352*)
 - ACCOUNT 461 Advanced Accounting (*prereq. 343*)
 - ACCOUNT 466 Advanced Managerial Accounting (*prereq. 356*)
 - ACCOUNT 475 Advanced Auditing (*prereq. 465*)
 - additional electives:
 - ACCOUNT 285 Intro to Blockchain & Cryptocurrencies (*coreq. 244*)
 - ACCOUNT 463 Accounting for Nonprofit Organizations (*prereq. 341*)
 - ACCOUNT 467 Fraud Examination (*prereq. 343 AND 356*)
 - may *only* choose one from this group (to count towards the three-accounting elective requirement):
 - ACCOUNT 355 VITA (**Spring only**) (*coreq. 351 OR 352*)
 - ACCOUNT 357 Service in Accounting (**Fall only**) (*prereq. 249*)
 - ACCOUNT 493 Internship (*prereq. 343*)

Course prerequisites leading to 'advanced' accounting electives are summarized here, to assist with course sequence selections:

- ACCOUNT 249 (*prereq. 244*) → ACCOUNT 351 OR 352 (*prereq. 249*) → ACCOUNT 453 (*prereq. 351 OR 352*)
- ACCOUNT 249 (*prereq. 244*) → ACCOUNT 341 (*prereq. 249*) → ACCOUNT 343 (*prereq. 341*) → ACCOUNT 461 (*prereq. 343*)
- ACCOUNT 249 (*prereq. 244*) → ACCOUNT 341 (*prereq. 249*) AND 356 (*coeq. 341*) → ACCOUNT 466 (*prereq. 356*)
- ACCOUNT 249 (*prereq. 244*) → ACCOUNT 341 (*prereq. 249*) AND 354 (*coeq. 341*) → ACCOUNT 465 (*prereq. 341 AND 354*) → ACCOUNT 475 Advanced Auditing (*prereq. 465*)

Important Accounting Program Notes:

Account 493 (Accounting Internship) may be taken for 1-12 credits. An accounting major may take a maximum of 3 ACCOUNT courses in a single semester and no more than 9 units of ACCOUNT total. If a student is taking ACCOUNT 493 as their only course in a semester, that course may be taken for up to 12 units. The accounting department recommends that public accounting internships be completed during the spring semester.

The Accounting Department complies with UW-Whitewater's repeat policies. Under these policies an accounting major:

1. may repeat an accounting course in which they earned a C- grade or below for grade replacement.
2. may not repeat more than two accounting courses without permission from the Accounting Department.
3. may not repeat an accounting course if the student has received credit for a higher-level accounting course for which the course to be repeated is a prerequisite or co-requisite. For example, a student who has received credit for **ACCOUNT 341** may not repeat **ACCOUNT 250**.

College of Business and Economics Notes

Admission to the Upper Division Business Courses:

As a business major, you must be admitted to the upper-division to take 300- and 400-level business courses. Admission to upper-division business courses requires that you meet the following criteria:

1. Have 54 **or** more projected units. Projected units are the number of units that will be earned at the end of the present term.
2. Have finished **or** be registering for the last unique and lower-division business courses required for admission, indicated in **bold** on the previous page.
3. Have earned a combined (transfer and UW-Whitewater) GPA of at least 2.8.

After being admitted to upper-division business courses, you must maintain a 2.50 combined cumulative GPA to be able to continue enrolling in business courses.

To graduate, business students must have:

1. At least 120 Units
2. 2.50 combined cumulative GPA, 2.50 combined GPA in the major, 2.50 combined GPA in all subjects offered by the College of Business and Economics
3. Completed all course requirements of the degree and major.
