#### **Assistant Vice Chancellor for Student Affairs and Dean of Students**

University of Wisconsin-Stevens Point (2014-present)

The University of Wisconsin-Stevens Point is a public, four-year, regional comprehensive baccalaureate granting university of approximately 8,260 students, with two branch campuses as part of the state-wide Universities of Wisconsin system.

The Assistant Vice Chancellor and Dean of Students serves as deputy to the Vice Chancellor for Student Affairs in support of divisional goals and the mission of the institution. The AVC/DOS is also responsible for creating collaborative, student-centered partnerships across campus and with the community. The position oversees the Office of the Dean of Students in administering the UW Code of Conduct for all reports of student academic and non-academic misconduct, campus care teams, and coordination of AODA and interpersonal violence prevention and advocacy efforts. Role also chairs the Threat Assessment Team, is a Deputy Title IX Coordinator, serves as a member of the Emergency Operations Committee, and on the Clery Compliance Committee. The position has oversight of \$2,800,000, thirty staff, and five direct reports to include two Director positions.

- Created mission, vision, values, staffing structure, and protocols for the new Office of the Dean of Students.
- Established and chaired Bias Response Team and Clery Compliance Committee, conceptualized studentfocused Care Teams, and updated and expanded the Threat Assessment Team.
- Introduced and launched the Center for Prevention & Health Promotion which coordinates a comprehensive AODA program, interpersonal violence primary prevention, and mental health peer education program.
- Spearheaded campus-wise review of student-focused mental health resources and response protocols to include campus-wide suicide prevention and crisis messaging, creation of EAB/Navigate student help-seeking options, and the adoption of Mantra Whole Campus Care resulting in System-leading student engagement.
- Evaluated and launched campus programs to include innovative interpersonal violence prevention and
  response activities to include bystander intervention, requiring online and in-person IPV prevention
  education, IPV advocacy partnerships, the grant funded Safe Night Out Program in partnership with local law
  enforcement, adoption of the uSafeUS app, the Safe Bar program in collaboration with the Tavern League,
  the Red Folder Project for all faculty and staff, and resources specific for all incoming students.
- Drafted institution's first-ever Indigenous Land Recognition statement, advised Indigenous student organizations, coordinated law enforcement and student identity group meetings, and supported institutional anti-racism efforts by drafting action items for campus law enforcement and the institution.
- Led institutional compliance efforts as the Clery Compliance Officer and Deputy Title IX Coordinator/Interim Coordinator to include internal and external review of Clery Act compliance, internal and external review of Title IX response, updating institutional trainings and policy review processes, authoring the Annual Security Report and Annual Fire Safety Report, and updating all student-centered Title IX materials and protocols.

Colorado Mesa University is a public, four-year, selective, baccalaureate granting university that includes a parallel community college mission. CMU has an overall student population of approximately 10,600.

The Director of Residence Life is responsible for vision, leadership, curriculum, and supervision of a comprehensive, 2250 bed residence life program that includes ten professional staff and more than 150 student leaders. The position has auxiliary budget responsibility of more than \$12,000,000, which includes all employee salaries, benefits, departmental learning plan activities, and contributions to facility renovation and construction.

- Introduced budget rightsizing and cost saving measures reducing Residence Life budget by \$300,000.
- Led the development of the Residence Life Learning Plan which included a comprehensive assessment plan for evaluating student learning and understanding the student experience.
- Opened three new residence halls and facilitated the renovation/update of six other buildings.
- Conceived and implemented substance-free and study-intensive themed communities as well as Criminal Justice and Outdoor Experience Living-Learning Communities.
- Researched, wrote, and implemented University service/therapy animal, Good Samaritan/Medical Amnesty,
  Campus Video Surveillance policies, student conduct process, and created the Maverick Guide, a studentcentered, university-wide document that includes information about student resources, academic and
  behavioral misconduct policies.
