Housing

Rita M. Neuman, *Closing the Door on Cohabitants Under Wisconsin’s Open Housing Law*, 1995 Wis. L. Rev. 965. This article discusses the holding of a housing discrimination case (County of Dane v. Norman) that affects single-sex couples living together.

County of Dane v. Norman, 174 Wis.2d 683, 497 N.W.2d 714 (WI 1993). In this case, the Supreme Court of Wisconsin held that a landlord’s policy of not renting to unmarried persons who intended to live together did not violate county ordinance prohibiting housing discrimination based on marital status.

In re Guardianship of O.G.M-K., Wendy M., 2010 WI App 90, 787 N.W.2d 848 (Wis. Ct. App. 2010). The Wisconsin Court of Appeals held that same-sex partners in Wisconsin cannot file a joint petition to adopt a child because they are unmarried, according to the relevant state statute, Wis. Stat. Ann. § 48.82.

Rights to children/guardianship

In re Custody of H.S.H.-K., 193 Wis. 2d 649, 533 N.W.2d 419 (WI 1995). The Supreme Court of Wisconsin held that “a circuit court may determine whether visitation is in a child's best interest if the petitioner first proves that he or she has a parent-like relationship with the child and that a significant triggering event justifies state intervention in the child's relationship with a biological or adoptive parent.”

Gould v. Gould, 116 Wis. 2d 493, 342 N.W.2d 426 (WI 1984). Father petitioned for transfer of custody of his daughter. The circuit court transferred custody, and mother appealed. On review, the Supreme Court of Wisconsin held that the circuit court abused its discretion in basing its determination to transfer custody to father on its belief that the father's “traditional” home environment was better than the mom's “nontraditional” one.

In re Custody of Neven D.H., 2004 WI App 93, 272 Wis. 2d 796, 801, 681 N.W.2d 552, 554. A court may not base a placement decision on a parent's nonmarital sexual conduct or relationship with a third party absent specific evidence that the conduct or relationship in question has had or would have a significant adverse impact on the child. In this case, the trial court's comments reflect an impermissible consideration of her nonmarital relationship with a third party as a negative factor absent any showing that the relationship was harmful to the child, in violation of her associational rights.

In re Paternity of Christian R.H., 2011 WI App 2, 331 Wis. 2d 158, 163, 794 N.W.2d 230, 232-33. In this case, the Court of Appeals stated the following: “Wisconsin's artificial insemination statute creates a presumption that a husband whose wife is artificially inseminated with semen donated by another man is the “natural father” of the child...a same-sex partner of the child's biological mother can never receive the presumption of parenthood under Wis. Stat. § 891.40(1). The presumption operates only in favor of a male, as evidenced by the statute's use of the words “husband” and “father.” Further, same-sex couples can never satisfy the marital relationship described by the statute.

Herman, Gregg M. & Cooper, Lucy, *Third-Party Visitation in Wisconsin*, 74 Wisconsin Lawyer 10 (March 2001). This article discusses statutes and case law in Wisconsin that allow courts to order third-party visitation. While the “third-party” in these situations is often a grandparent, an individual in a same-sex partnership could potentially also petition for visitation in certain situations.

➤ Transgender Issues

Discrimination

Price Waterhouse v. Hopkins, 490 U.S. 228 (1989). The U.S. Supreme Court held that Title VII's prohibition of discrimination "because of . . . sex" bars gender discrimination, including discrimination based on sex stereotypes, that is, discrimination because she failed to *act* like a woman. Therefore, the Supreme Court held that employers may no longer discriminate against someone who does not conform to stereotypical gender norms.

Spearman v. Ford Motor Co., 231 F.3d 1080 (7th Cir. 2000) – In this case, the United States Court of Appeals, Seventh Circuit, stated that, "The plaintiff must show that the employer actually relied on [the plaintiff's] gender in making its decision...we must consider any sexually explicit language or stereotypical statements within the context of all of the evidence of harassment in the case, and then determine whether the evidence as a whole creates a reasonable inference that the plaintiff was discriminated against because of his sex.
